“Participant” is defined as any person on the premises of Frazier’s Homestead, for any reason, including but not limited to, dropping off and picking up children.

- I recognize the risk of injury inherent in or incidental to being in the proximity of horses, or the handling and riding of horses due to their size and unpredictability.
- I recognize the risk of injury inherent in or incidental to riding in motorized vehicles such as automobiles, trucks, tractors, ATVs (4-wheelers), and golf carts used in the operation of a horse ranch and riding facility and specifically, the risk involved in riding in an automobile during transportation to and from Frazier’s Homestead and Frazier’s personal residence at 8877 Comite Dr., Baker, LA 70714, a distance of approximately 1.5 miles, for the purpose of swimming.
- I recognize the risk of injury inherent in the act of swimming in a pool as deep as 6 feet.
- I voluntarily assume all of the risks noted above and give permission for my child(ren) to participate in **equine and swimming activities and ride in motorized vehicles**, and release Frazier’s Homestead, owners, Michael and Deidra Frazier, and any staff member of Frazier’s Homestead, from any or all liability for injuries, including serious injury or death. I shall bring no claims, demands, actions, or causes and/or litigation against the above parties, individuals or business for any economic or noneconomic loss/losses due to physical harm, mental harm or anguish, bodily injury, death, or property damage sustained by

me, the authorizing parent/legal guardian,

caused by any animal, horse, tack, or equipment (including but not limited to the tractor, backhoe, golf cart, four-wheelers) at or in relation to the premises and operations of Frazier’s Homestead (including but not limited to the woods, trails, pastures, river and associated areas of quicksand or debris, areas surrounding the remains of old structures which may have hazardous debris, any and all manner of structures including but not limited to fences constructed of barbed wire or other potentially dangerous materials, the arena, round pen, machinery, barns, tack rooms, or storage rooms) while walking, riding or handling horses and or otherwise being in the vicinity of any/all animals or poisonous plants, on the premises.

RS.9:2795.1

Under Louisiana law, a farm animal activity sponsor or farm animal professional is **not liable** for an injury to or the death of a participant in farm animal activity resulting from the inherent risks of the farm animal activity, pursuant to RS.9:2795.1.
